Having read the AHCS Article Submission Guidelines, please read and complete the form below, and return to the AHCS when you submit your article.

Please note that submitting an article to the AHCS automatically implies:

- The article is original, unpublished and you are the sole author of the article. If there is more than one author, the additional authors must also give permission for the article to be published by the AHCS, as per the terms laid out in this document and the AHCS Article Submission Guidelines.
- You are giving the AHCS permission to publish the article (and any illustrations supplied) in AHCS print publications and/or on AHCS websites, in any format (i.e. as an item in *HCS Leadership Journal* or a PDF on the AHCS website).
- The AHCS has first publishing rights (this means that the same article will not be published by another third party in advance of the publication date agreed by the AHCS).
- You are giving the AHCS the right to edit your article to meet house style and fit the space available. A copy of the edited version can be supplied prior to print, on request.
- Full references have been provided, and permissions granted to publish quotes and excerpts, where appropriate.
